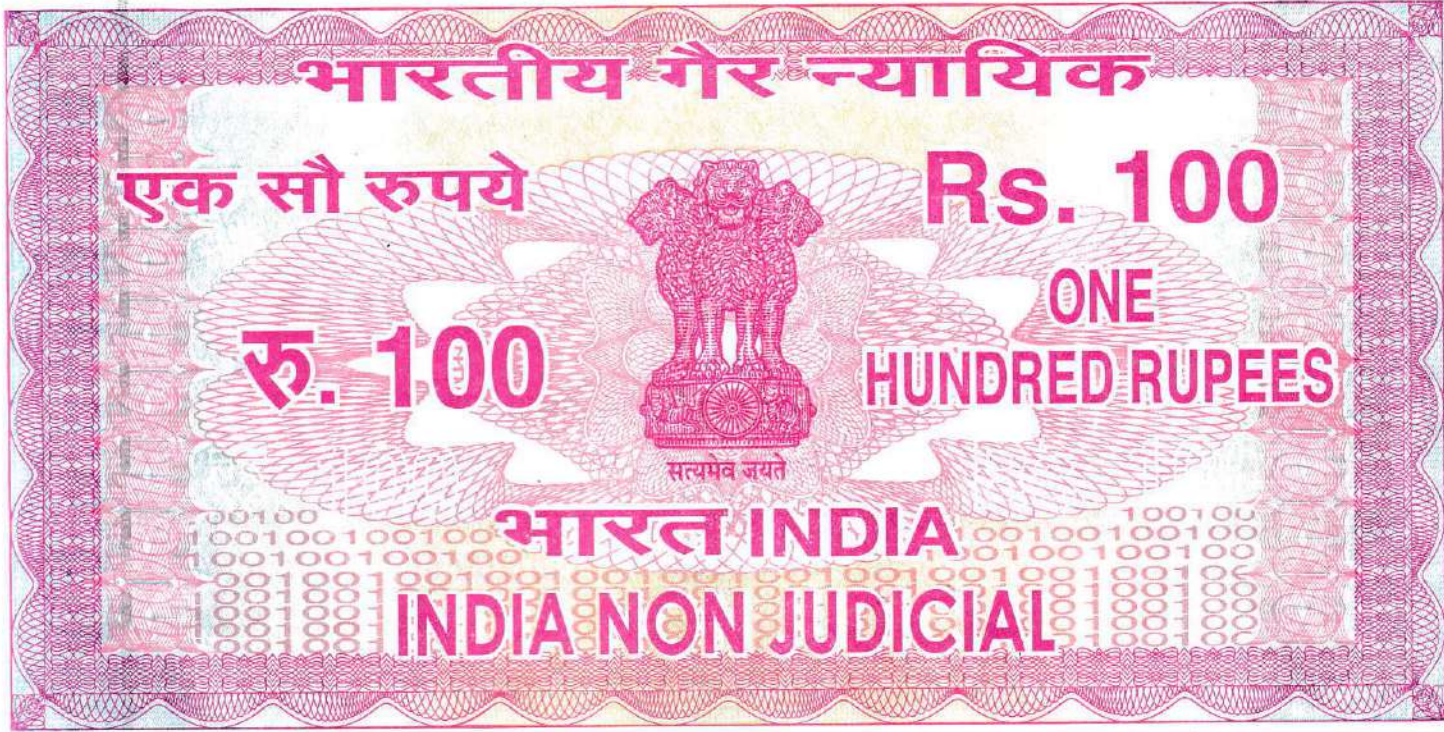

The above sanction is subject to fulfillment of following condition.

- 1) The grant of recognition is not extendable and does not in any way imply any obligation to recognize/ affiliate beyond Class VIII.
- 2) The School shall abide by the provisions of Right of Children to Free and Compulsory Education Act, 2009 (Annexure –I) and the Right of Children to Free and Compulsory Education Rules, 2010 (Annexure – II)
- 3) The School shall admit in Class I (or in pre-school class, as the case may be), to 25% of the strength of that class, children belonging to weaker section and disadvantage group in the neighbourhood and provide free and compulsory elementary education till completion.
- 4) For the children referred to in paragraph 3, the School shall be reimbursed in accordance with the provisions of sub-section (2) of section 12 of the Act. To receive such reimbursements school shall maintain a separate bank account.
- 5) The Society/School shall not collect any capitation fee and subject the child or his her parent or guardian to any screening procedure.
- 6) The School shall not deny admission to any child for lack of age of proof shall adhere to the provisions of section 15 of the Act.
- 7) **(One)** The school shall ensure that No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school.

- (Four)** Every child completing elementary education shall be awarded a certificate as laid down under rule 23.
- (Five)** Inclusion of Students with disabilities/special needs as per provision of the Act.
- (Six)** The teachers are recruited with minimum qualification as laid under section 23 (1) of the Act. Provided further that the current teachers who, at the commencement of this Act do not possess minimum qualification shall acquire such minimum qualification within a period of 5 years.
- (Seven)** The teacher performs its duties specified under section 24(1) of the Act.
- (Eight)** The teachers shall not engage himself or herself for private teaching activities.
- 9) The School shall follow the syllabus on the basis of curriculum laid down by appropriate authority.
- 10) The School shall maintain the standards and norms of the school as specified in section 19 of the Act.
